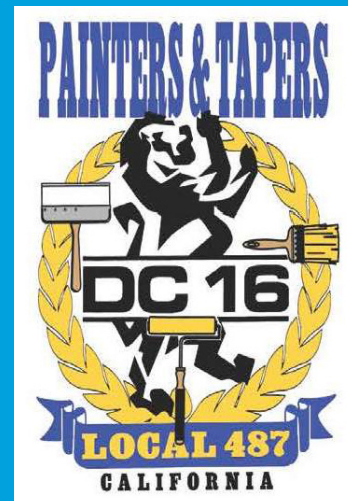

Sacramento/Monterey Area Addendum to the Northern California Drywall Finishers Master Agreement

This Area Addendum to the Northern California Drywall Finishers Master Agreement shall only apply to Employers signatory to this Area Addendum performing covered work within Alpine, Amador, Butte, Calaveras, Colusa, Del Norte, El Dorado, Glenn, Humboldt, Lake, Lassen, Mariposa, Mendocino, Merced, Modoc, Monterey, Nevada, Placer, Plumas, Sacramento, San Benito, San Joaquin, Santa Cruz, Shasta, Sierra, Siskiyou, Stanislaus, Sutter, Tehama, Trinity, Tuolumne, Yolo and Yuba Counties.

Drywall Finishing Contractors signatory to this Area Addendum working within Alpine, Amador, Butte, Calaveras, Colusa, Del Norte, El Dorado, Glenn, Humboldt, Lake, Lassen, Mariposa, Mendocino, Merced, Modoc, Monterey, Nevada, Placer, Plumas, Sacramento, San Benito, San Joaquin, Santa Cruz, Shasta, Sierra, Siskiyou, Stanislaus, Sutter, Tehama, Trinity, Tuolumne, Yolo and Yuba Counties, as defined above, shall have Article 8 Section 1(a) of the Northern California Drywall Finishers Master Agreement amended to read as follows:

Section 1. Journeyman Rate:

- (a)** The rate of pay for Journeyperson Drywall Finishers working under this Sacramento/Monterey Area Addendum shall be pursuant to the Sacramento/Monterey Area Addendum Wage Schedule A (attached) and the Total Package Wage shall be increased by five dollars (\$5.00) per hour on July 1, 2026, and the Total Package Wage shall be increased by five dollars (\$5.00) per hour on July 1, 2027, and the Total Package shall be increased by five dollars (\$5.00) per hour on July 1, 2028, and the Total Package Wage shall be increased by five dollars (\$5.00) per hour on July 1, 2029, of this Agreement and/or any extensions thereof.

All other terms and provisions of the Northern California Drywall Finishers Master Agreement shall apply. This Sacramento Area Addendum in no way effects the interpretation and/or application of any other Articles and/or Sections of the Northern California Drywall Finishers Master Agreement.
